General Instructions

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following:

- Form 1099-INT (interest earned or paid)
- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)

- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

FORM CIQ

This questionnaire reflects changes made to the law by H.B. 23, 84th Leg., Regular Session.

This questionnaire is being filed in accordance with Chapter 176, Local Government Code, by a vendor who has a business relationship as defined by Section 176.001(1-a) with a local governmental entity and the vendor meets requirements under Section 176.006(a).

By law this questionnaire must be filed with the records administrator of the local governmental entity not later than the 7th business day after the date the vendor becomes aware of facts that require the statement to be filed. See Section 176.006(a-1), Local Government Code.

A vendor commits an offense if the vendor knowingly violates Section 176.006, Local Government Code. An offense under this section is a misdemeanor.

Directions for completion for FORM CIQ—Vendor Questionnaire

1. Name of vendor's business/company **EX:** *2nd State Bank of Dollar City*
2. Check only if this questionnaire is a follow up to a previously filed form
3. If the vendor has no knowledge of a conflict of interest with an employee, an administrator or a school board member, then the answer to #3 is "NONE", in which case you may skip down to question #4, sign and date for completion of the form.

However, if there IS a conflict of interest in regards to the vendor and an employee, or an administrator or a school board member and/or a member of their family in the first degree, question #3 should be completed with the name(s) of the person(s) who have a business relationship with the vendor and the type of relationship that causes the potential conflict of interest. **EX:** *Jane Doe, wife of John Doe, who is an Era ISD school board member, has an interest bearing account in her at 2nd State Bank of Dollar City.*

Item A is to check whether or not the affected person from #3 is receiving or is likely to receive any taxable income from the vendor. Item B is to determine if the vendor is receiving or is likely to receive any taxable income from any actions on the part of an employee, school board member or administrator. Item C is to determine if the vendor is affiliated with a business in which an employee, or an administrator, or a school board member serves on the board of directors for the vendor's business/corporation, is a part or full owner of the business. Item D is to simply describe any and all other relationships that would help to disclose a potential conflict of interest between a vendor and an employee, or an administrator, or a school board member and/or their families in the first degree.
